AIAC Inc Bylaws

Version 2 - 28 May 2023

1. AIAC Inc Model Rules

The Anderson Inlet Angling Club (AIAC) Inc adopted the Model Rules on 23 March 2017. The Model Rules are developed and updated from time to time by Consumer Affairs Victoria for use by an Incorporated Association.

The AIAC Inc Bylaws provide additional rules and information, required to support the management of the AIAC Inc that are not included in the AIAC Inc Model Rules.

In the unintended event that the AIAC Inc Bylaws contradict the AIAC Inc Model Rules then the AIAC Inc Model Rules take precedence.

These AIAC Inc Bylaws can be amended by Special Resolution at a General Meeting in accordance with the AIAC Inc Model Rules.

2. AIAC Inc Branding

- The AIAC Inc colours shall be Red and White.
- The AIAC Inc name can only be used on external communication, advertising and/or merchandise when specifically approved by the AIAC Inc Committee.
- The AIAC Inc logo can only be used on external communication, advertising and/or merchandise when specifically approved by the AIAC Committee.

3. External Communication to Third Parties

- All external communication involving any business of the AIAC Inc must be reviewed and specifically approved by the AIAC Inc Committee prior to being released.
- The AIAC Inc Committee shall specifically authorize who can provide external communication on AIAC Inc activity once the external communication has been approved by the AIAC Inc Committee.
- No member of the AIAC Inc shall publish or cause to be published any information related to AIAC Inc business unless specifically authorized by the AIAC Inc Committee.

4. Internal Communication to Members

- All internal communication to members must be reviewed and specifically approved by the AIAC Inc Committee prior to being released.
- The AIAC Inc Committee will specifically authorize who can provide internal communication on AIAC Inc activity once the internal communication has been approved by the AIAC Inc Committee.
- The AIAC Inc Committee may from time to time authorize specific Committee Members to develop and issue "business as usual" communications that are a normal part of the role and responsibilities of a specific Committee Member.
- AIAC Inc membership contact details are only for use by the AIAC Inc Committee for the management and administration of the club.

5. Membership

The general rights of all members are contained in the AIAC Inc Model Rules and which identifies two basic membership categories:

- 1. Member
- 2. Associate Member

Note: Associate Members are not entitled to vote as per the AIAC Inc Model Rules.

 2 Family membership consist of a maximum of 2 Full (parents or guardians) Members and up to 4 Junior Associate (children less than 15 years old) Members from the same immediate family.

5.1 Life Membership

The award of Life Membership to the AIAC Inc is as special recognition to a member who has provided extraordinary service and/or who has completed at least twenty (20) years service to the AIAC Inc.

A nomination for life membership shall be made in writing to the AIAC Inc Secretary or a member of the AIAC Inc Committee and will be confidential. The AIAC Inc Committee shall be the sole decider in granting a life membership.

The life member shall be liable to meet the cost of liability insurance subscription, all competition fees, and social fees and other charges as set by the AIAC Inc

5.2 Membership Fees

- AIAC Inc membership fees are paid annually.
- Membership fees and due dates are reviewed annually and are confirmed at the Annual General Meeting.
- Applicable membership fees are included on the current AIAC Inc Application for Membership form.

6. Fishing Competitions

- Eligibility to enter AIAC Inc fishing competitions is based on AIAC Inc membership type.
- From time to time the AIAC Inc Committee may invite guests of the AIAC Inc to enter AIAC Inc fishing competitions.
